

QUITCLAIM DEED

That the Parties of the First Part, for and in consideration of the sum of TEN (\$10.00) Dollars, lawful money of the United States of America, and other good and valuable consideration, to them in hand paid, the receipt whereof is hereby acknowledged, do by these presents release and forever QUITCLAIM unto the Parties of the Second Part, not as tenants in common, but as JOINT-TENANTS with the right of survivorship, all those certain lots, pieces or parcels of land situate, lying and being in the Town of Eureka, County of Eureka, State of Nevada, and more particularly bounded and described as follows:

Lots One (1) and Two (2), and East Thirty-four (34) Feet of Lot Three (3) in Block 122, in the Town of Eureka, County of Eureka, State of Nevada;

Plot One Hundred (100) Feet square in West and Center of Lot One (1), Block 123, in the Town of Eureka, County of Eureka, State of Nevada;

Together with the dwelling and other improvements thereon situate.

TOGETHER with all and singular the tenements, hereditaments, improvements and appurtenances thereunto belonging or in anywise appertaining, and the reversion and reversions, remainder and remainders,

rents, issues and profits thereof.

TO HAVE AND TO HOLD the said premises, together with all and singular the appurtenances unto the said Parties of the Second Part as JOINT-TENANTS and to the survivor of them forever.

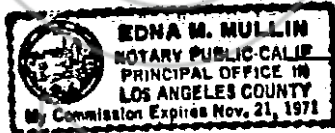
