

Certificate of Location of Lode Mining Claim

The locator claim S 50 feet in a Northwesterly direction and 1750 feet in a Southerly direction from the point of discovery, with a width of 600 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows: An open cut 3ft deep by 10 feet wide by 30 feet long about 40 feet in a westerly direction from the discovery monument.

The total cost of such work consisted of at least \$100.

From the North West corner, a monument marked Lassie #1 N.W. Cor., thence in a Easterly direction 600 feet to the North East corner, a monument marked Lassie #1 N.E. Cor., thence 750 feet in a Southerly direction to the East side center, a monument marked Lassie #1 East SC, thence 750 feet in a Southerly direction to the South East corner, a monument marked Lassie #1 S.E. Cor., thence 600 feet in a Westerly direction to the South West corner, a monument marked Lassie #1 S.W. Cor., thence 750 feet in a Northwesterly direction to the West side center, a monument marked Lassie #1 West SC, thence 750 feet Northwesterly to the point of beginning.

The general course of said lode or vein is Westerly and Easterly. The claim is situated in the Corte Mining District, Esmeralda County, State of Nevada.

The North side of this claim overlaps the South end of the Highland Lassie and the South side overlaps the north side of the Buddy claim, in Mill Canyon.

The locator claim is 750 feet in an Westerly direction and 750 feet in an Easterly direction from the point of discovery, with a width of 600 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows: An open cut 2 feet deep by 12 feet wide by 24 feet long about 12 feet in an Easterly direction from the discovery monument.

The total cost of such work consisted of at least \$100.

The corners and side centers of the claim are located and marked as follows:

From the North West corner, a monument marked Lassie #2 N.W. Cor., thence in a Southerly direction 600 feet to the South West corner, a monument marked Lassie #2 S.W.
