

CERTIFICATE OF LOCATION OF LODE MINING CLAIM (GROUP OF CLAIMS)

The general course of said lode or vein is northwest, and the undersigned claims 10 feet in a westerly direction and 1490 feet in an easterly direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The location work was done upon the Sun # 12 claim(s) for the benefit of a contiguous group of not more than ten (10) Lode Mining Claims, the specific names of which are as follows: Sun # 1-3-5-6-7-8-9-10-11-12

The location work done consisted of: Drilling costing a total of \$ 1000.00, of which \$100.00 is applicable to this claim.
