

LOCATION CERTIFICATE

This is to certify that the A No. 12 lode mining claim was located by Byron S. Hardie on the 13th day of April, 1968.

The general course of said vein or lode, as near as it may be described is S 17° E and N 17° W.

The claim is situated in the Bootstrap mining district, Eureka County, State of Nevada, and the discovery monument is located approximately N 80 1/2° E 4900 feet from the west 1/4 corner of Section 22, T. 36 N.; R. 49 E.; M. D. B. & M.

The locator claims 50 feet in a S 17° E direction and 1450 feet in a N 17° W direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claims are as follows: three rotary drill holes, 45 feet deep, 85 feet deep and 75 feet deep on the "A" claim Nos. 10, 11 and 12, and costing more than \$600.00. Such work was done at 3 point(s) within a group of contiguous claims and results in tending to advance the exploration of such claims as a group. The names of which said group of claims are as follows: A Nos. 3, 4, 5, 10, 11 and 12.

The corners and side centers of this claim are located and marked as follows:

Beginning at the northwest corner, a 4"x4"x4 1/2' wood post marked N.W. corner A No. 12; thence S 17° E 750 feet, west side center, a 4"x4"x4 1/2' wood post marked W side center, A No. 12, 1500 feet to the SW corner, a 4"x4"x4 1/2' wood post marked SW corner A No. 12; thence N 73° E 600 feet to the southeast corner, a 4"x4"x4 1/2' wood post marked SE corner A No. 12; thence N 17° W 750 feet, east side center, a 4"x4"x4 1/2' wood post marked E side center, A No. 12, 1500 feet to the NE corner, a 4"x4"x4 1/2' wood post marked NE corner A No. 12; thence S 73° W 600 feet to the northwest corner, the place of beginning.

The west side line of this claim is contiguous with the east side line of the A No. 11 claim; the south end line is contiguous with the north end line of the A No. 5 claim; the east side line is contiguous with the west side line of the A No. 13 claim; the north end line is contiguous with the south end line of the Rio No. 6X claim.

All location work necessary to complete this location had been performed by June 19, 1968.
