thence N. 17° W ..... 750 ..... feet, ..... east ..... side center,  
a 4"x4"x4 1/2' wood post marked E ..... side center, ..... A. No. 13, 1500 ..... feet to the NE ..... corner,  
a 4"x4"x4 1/2' wood post marked NE ..... corner ..... A. No. 13 ..... ;  
thence S. 73° W ..... 600 ..... feet to the northwest corner, the place of beginning.
