EXCATION CERTIFICATE

THIS IS TO CERTIFY that the RX-/37 lode mining claim was located by Homestake Mining Company, whose present address is 650 California Street, San Francisco, California 94108, on the 4 day of JUNE 1968

The general course of said vein or lode as near as it may be described is easterly and westerly. The claim is situated in Cortez Mining District in Eureka County, State of Nevada, and the discovery monument is located approximately <u>5/00</u> feet from the southeast corner of Section 3, Township 26 North, Range 48 East.
