

The undersigned, Grantor, grants to BELL TELEPHONE COMPANY OF NEVADA, a corporation, its successors and assigns, Grantee, a right of way, with the right to construct, place, inspect, maintain, remove, repair, replace, use, operate and patrol such aerial wires, cables and other electrical conductors with associated poles, crossarms, anchors, guys and fixtures, as Grantee may from time to time require, and with the right of access thereto, across and upon the following described property in the Counties of Eureka and Lander, State of Nevada:

The northwest quarter of the southwest quarter of the northwest quarter (NW 1/4 of SW 1/4 of NW 1/4) and the southwest quarter of the northwest quarter of the southwest quarter (SW 1/4 of NW 1/4 of SW 1/4) of Section 29, Township 29 North, Range 48 East, M.D.B. & M.

Said right of way comprises the easterly ten (10) feet of the westerly thirty (30) feet of the above described real property, except at those locations where it is necessary to construct, locate and install guys with anchorage; then said right of way is to include said guys and anchors, which are not to be constructed beyond a maximum distance of ten (10) feet from said right of way.

Grantor also grants to Grantee the right to trim any trees along said wires, cables, conductors and poles whenever considered necessary by Grantee for the complete enjoyment of the rights hereby granted.
