

CERTIFICATE OF MINING LOCATION

TO ALL WHOM IT MAY CONCERN

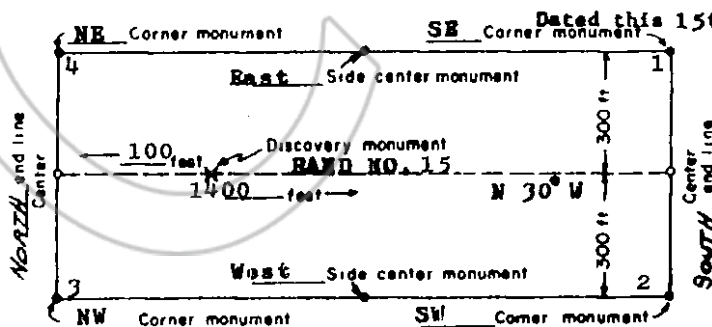
The undersigned hereby certifies that he has located the **RAND NO. 15 Mining Claim** in the unknown Mining District, in **Eureka County, in the State of Nevada**, on the **1st** day of **June 1968**, at **1:45 p.m.**

The length of the claim is **1500 feet**, and **100 feet** is claimed in a northwesterly direction, and **1400 feet** in an southeasterly direction from the discovery monument, at which the notice of location is posted, lengthwise of the claim, together with **300 feet** in width on each side of the center of the claim. The general course of the lode deposit and premises is from the **South 30° East to North 30° West**.

The location of the claim is described with reference to the **NE corner of Section 22, T22N, R49E, Mount Diablo Meridian**, which bears about **S 52-20° W**, about **8,410 feet**, from corner no. 1 of **RAND NO. 15 Claim**. Corner no. 1 of **Rand No. 15 Claim** is identical with corner no. 1 of **Rand No. 19 Claim**.

The surface boundaries of the claim are marked upon the ground as follows: Beginning at a point in a **S 30° E** direction **1400 feet** from the discovery monument (at which the notice of location is posted), being in the center of the south end line of said claim; thence **S 60° W 300 feet** to a **4" X 4" redwood post 4½' hi.** being the **SW No. 2 corner** of said claim; thence **N 30° W 750 feet** to a **8" dia. 5' hi. topped juniper** being at the center of the west side line; thence **N 30° W 750 feet** to a **5" dia. 5' hi. topped juniper tree** being the **NW No. 3 corner** of said claim; thence **N 60° E 300 feet** to the center of the north end line of said claim; thence **N 60° E 300 feet** to a **8" dia. 6' hi. pinon tree topped** being the **NE No. 4 corner** of said claim; thence **S 30° E 750 feet** to a **5" dia. 5' hi. topped juniper** being at the center of the east side line; thence **S 30° E 750 feet** to a **6" dia. 5' hi. topped juniper tree** being the **SE No. 1 corner** of said claim; thence **S 60° W 300 feet** to the center of the south end line of said claim, at the place of beginning. Metal tags, marked with appropriate corner descriptions, as described above, are affixed to the monuments. The boundaries of the claim were completed **June 20, 1968**.

A description and the location of the work done upon the claim is as follows: An open cut and excavation has been dug along the ledge or lode, the size of which is at least **4 feet by 6 feet by 10 feet**, located at the discovery monument, and excavation work done at various points on the **Rand No. 15 claim**.
