

**CERTIFICATE OF MINING LOCATION**

TO ALL WHOM IT MAY CONCERN

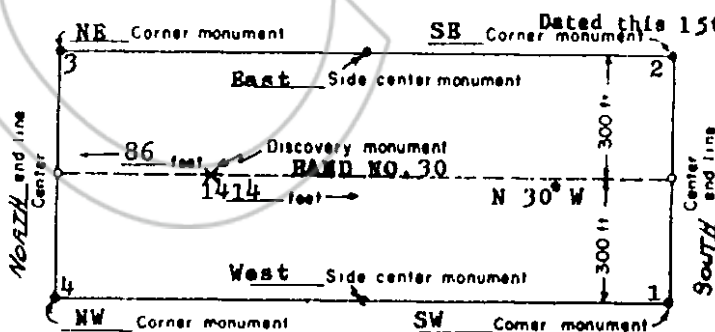
The undersigned hereby certifies that he has located the  
**RAND NO. 30 Mining Claim** in the unknown Mining District, in  
 Eureka County, in the State of Nevada, on the 1st day of July  
 1968, at 11:00 a.m.

The length of the claim is 1500 feet, and 86 feet is  
 claimed in a northwesterly direction, and 1414 feet in an  
 southeasterly direction from the discovery monument, at which the  
 notice of location is posted, lengthwise of the claim, together  
 with 300 feet in width on each side of the center of the claim.  
 The general course of the lode deposit and premises is from the  
 South 30° East to North 30° West.

The location of the claim is described with reference to the  
 NE corner of Section 22, T22N, R49E, Mount Diablo Meridian, which  
 bears about N 89° 50' W, about 9,620 feet, from corner no. 1  
 of RAND NO. 30 Claim. Corner no. 2 of Rand No. 30 Claim is  
 identical with corner no. 2 of Rand No. 34 Claim.

The surface boundaries of the claim are marked upon the  
 ground as follows: Beginning at a point in a S 30° E direction  
 1414 feet from the discovery monument (at which the notice  
 of location is posted), being in the center of the south end  
 line of said claim; thence N 60° E, 300 feet to a 5" dia. 6' hi. juniper post  
 being the SE No. 2 corner of said claim; thence N 30° W, 750 feet  
 to a 5" dia. 6' hi. juniper post being at the center of the  
 east side line; thence N 30° W, 750 feet to a 12" dia. 13' hi. topped  
 pinon tree being the NE No. 3 corner of said claim; thence  
 S 60° W, 300 feet to the center of the north end line of said claim;  
 thence S 60° W, 300 feet to a 4½" dia. 5' hi. juniper post being  
 the NW No. 4 corner of said claim; thence S 30° E, 750 feet to a  
 5" dia. 5' hi. topped pinon tree being at the center of the west  
 side line; thence S 30° E, 750 feet to a 4" dia. 5' hi. topped pinon tree  
 being the SW No. 1 corner of said claim; thence N 60° E, 300  
 feet to the center of the south end line of said claim, at the  
 place of beginning. Metal tags, marked with appropriate corner  
 descriptions, as described above, are affixed to the monuments.  
 The boundaries of the claim were completed July 21, 1968.

A description and the location of the work done upon the claim  
 is as follows: An open cut and excavation has  
 been dug along the ledge or lode, the size of which is at least  
 4 feet by 6 feet by 10 feet, located at the discovery monument, and  
 excavation work done at various points on the Rand No. 30 claim.
