Said labor was performed during the period between September 1, 1967 and August 31, 1968.

That such work consisted of a geochemical soil, rock and sediment survey on all of the above named claims. The samples were analyzed for gold by atomic absorption spectrophotometry by Rocky Mountain Geochemical Corporation, Salt Lake City, or Skyline Labs, Inc., Denver. The geochemical survey showed anomalies in gold, silver, and cold extractible

heavy metals. The geochemical survey was conducted by Lyle F. Campbell, Box 7377, Reno, Nevada, a B.S., Mining Engineering, graduate of the University of Minnesota, and a graduate of the Colorado School of Mines snort course in geochemistry who has been practising his profession for 19 years.

That all of said work was done and performed for the benefit of each and all of the unpatented lode mining claims hereinabove named.

That all expenditures were made at the expense of Lyle F. Campbell for the purpose of complying with the laws of the State of Nevada and the United States in the performance of annual assessment work to maintain title to unpatented lode mining claims; that said work was done by or for and on behalf and for the benefit of Lyle F.
