Such work or improvements, and character, consisted of drill site access roads, geochemical surveys and geologic surveys of the area of the subject claims. The work was performed by Julian E. Simpson, Engineer of Mines, and Damele Brothers contractors. These surveys revealed a north west trending structure displaced at intervals by high angle cross faults. Devils Gate Limestone Formation ( Devonian age ) and Vinini Formation ( Ordovician age ) are the stratigraphic units exposed. Geochemical analyses were made by Skyline, Labs of Denver, Colorado. Geochemical maps of samples collected in the claims area were prepared.
