Such work or improvements, and character, consisted of geochemical surveys and geologic surveys of the area of the subject claims. The work was performed by Julian E. Simpson, Engineer of Mines. These surveys revealed a northerly trending structure containing grabens of Devils Gate Limestone Formation (Devonian age) bounded by high angle faults and the Vinini Formation (Ordovician age). Geochemical analyses were made by Rocky Mountain Geochemical Corp. of Salt Lake City, Utah, and Skyline, Labs. Inc. of Denver, Colorado. Geochemical maps of samples collected in the claim area were prepared.
