PROOF OF LABOR ON THE Element #1 through Element #68 (68 claims), lode mining claims situated in the Maggie Creek mining district Eureka County, Nevada and owned by Fred Pacini.

TO WHOM IT MAY CONCERN: Please take notice that: James V. Muth, agent for G. M. Wallace & Company, of 203 Pine Street, Elko, Nevada, deposes and says: That G. M. Wallace & Company is the holder of an Option Agreement to purchase the herein described unpatented lode mining claims and have assumed the responsibility for completion of the assessment work for the period ending September 1, 1968.

a. Not less than \$100.00 was expended on, or for the benefit of, each of the sixty eight (68) claims, an amount totalling not less than \$6800.00.

b. The character of expenditures, labor and improvements included:

1. Geologic examination.
2. Mapping.
3. Sampling and assaying.
4. Road construction.
5. Drill-site preparation.
6. Drilling.

c. Geologic examination and mapping included all claims as well as sufficient surrounding area for proper correlation.

Sampling and assaying was conducted for all drill holes as well as at the surface over much of the area.

Road construction included three miles of access road on claims Element nos. 15, 16, 17, 22, 23, 24, 37, 38, 39, 47, 48, 49, 50, 51, 57, 58, 59, 60, 61, 62, 63, 64, and 65, (23 claims).

Drill sites were prepared on Element claims nos. 48, 49, 50, and 51.

Drill holes were completed on Element claims nos. 40, 48, and 49.

Labor and supervision was provided for the above work.

All of the above listed work and improvements has advanced the exploration of, and was accomplished for the benefit of, all of the claims for which this affidavit is presented.

d. Such labor and improvements were accomplished on the following dates:

Geologic examination, mapping, sampling and assaying began in December, 1967, and has continued intermittently throughout the remainder of the assessment year.

Road work began on August 7, 1968, and was completed on August 12, 1968.

Drilling was accomplished March 28, 1968 through April 5, 1968, May 24 through May 26, 1968, May 28 through June 4, 1968, July 27, 1968 August 31 through September 1, 1968.
