That at the instance of the affiant, CARLIN GOLD MINING COMPANY, that it expended more than one hundred dollars (\$100.00) per claim for labor or improvements, as the annual assessment work for the year ending September 1, 1968, on or for the benefit of all of the aforesaid claims, in the Lynn Mining District, Eureka County, Nevada, owned by Carlin Gold Mining Company, for the purpose of holding all of the aforesaid claims.

Said labor was performed by employees and contractors, Worthington Construction and its employees, Eklund Drilling Company and its employees, between the first (1st) day of September, 1967 and the fifth (5th) day of September, 1968, and more than 60 days of labor were performed. Such work or improvements, and character consisted of construction of access roads, preparing drill ~~shafts~~^{sites}, and the drilling of 535' feet in four rotary drill holes, and the construction of 10 exploration trenches totaling 3,080' in length and averaging 8' in depth. Such work was performed on Pete Claim No. 17 and Roy Claim No. 2, Roy Claim No. 3, Roy Claim No. 4, and Roy Claim No. 12.

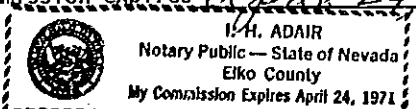
