THIS INDENTURE made this 18<sup>th</sup> day of September, 1968, by and between JOAN SHANGLE, Treasurer of Eureka County, Nevada, party of the first part, and PETER MERIALDO, whose address is 921 West King Street, Carson City, Nevada, party of the second part, the heirs and devisees of ED DELANEY, Deceased, c/o George Hawes, party of the third part, and PETER T. W I T N E S S E T H:

designated by the Surveyor General of the United States of America as Survey No. 4537, and being the subject matter of United States of America Patent No. 916505.

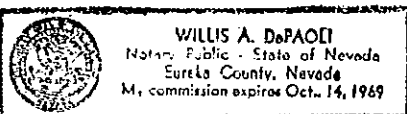
