

Certificate of Location of Lode Mining Claim

THIS IS TO CERTIFY that the CRD#5 Lode Mining Claim was located by CARL DREW, whose post office address appears below, on the 10 day of August, 1968.

The general course of said lode or vein is Northerly & Southerly

The claim is situated in the Lynn Mining District, EUREKA County, State of Nevada, Section 30 - Twp 36N Rge 50E M.D.M

The locator claim 600 feet in a Northerly direction and 600 feet in a Southerly direction from the point of discovery, with a width of 100 Feet on The Westerly Side and 225 feet on The Easterly side of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows: Three Trenches At Extreme North End of CRD#1. A Total of more than 600 Cubic Feet of Earth was Removed, CRD#5, Two Trenches At Discovery Monument, A Total of more than 450 Cubic Feet of Earth was Removed, CRD#6. Two Trenches at Discovery Monument, and Trench 150 feet NE of The S.W. Corner of Claim, A Total of more than 600 Cubic Feet of Earth was Removed, CRD#1, CRD#5, CRD#6, CRD#7, CRD#8, Are Contiguous Lode Claims, and All Discovery Work was to Advance The Exploration on All Claims.

The total cost of such work consisted of at least \$ 500.00

The corners and side centers of the claim are located and marked as follows:

From the South West corner, a monument marked CRD#5 SW Cor., thence in a Easterly direction 325 feet to the South East corner, a monument marked CRD#5 SE Cor., thence 600 feet in a Northerly direction to the EAST side center, a monument marked CRD#5 EAST SC, thence 600 feet in a Northerly direction to the North East corner, a monument marked CRD#5 N.E. Cor., thence 325 feet in a Westerly direction to the North West corner, a monument marked CRD#5 N.W. Cor., thence 600 feet in a Southerly direction to the West side center, a monument marked CRD#5 West SC, thence 600 feet Southerly to the point of beginning.

Each of the above-described monuments is 4x4 Post 4 1/2 feet in length
