

# Certificate of Location of Lode Mining Claim

THIS IS TO CERTIFY that the C.R.D # 8 Lode Mining Claim was located by CARL DREW, whose post office address appears below, on the 10 day of August, 1968.

The general course of said lode or vein is Northwesterly & Southerly.

The claim is situated in the Lyon Mining District, EUREKA, County, State of Nevada, Section 30, Twp. 36N, Rge 50E, M. D. M.

The locator claim 425 feet in a Southerly direction and 425 feet in a Northerly direction from the point of discovery, with a width of 100 feet on the Westerly side and 225 feet on the side of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows: At the Extreme North End of CRD#1, A TOTAL OF MORE THAN 600 CUBIC FEET OF EARTH WAS REMOVED CRD#5 TWO TRENCHES AT THE DISCOVERY MEASUREMENT. A TOTAL OF MORE THAN 450 CUBIC FEET OF EARTH WAS REMOVED. CRD#6 TWO TRENCHES AT DISCOVERY MEASUREMENT, AND TRENCH 150 FT NORTHEAST OF THE S.W. CORNER. A TOTAL OF MORE THAN 600 CUBIC FEET OF EARTH WAS REMOVED. CRD#7, CRD#5, CRD#6, CRD#7, CRD#8, ARE CONSEQUENT LODE CLAIMS, AND ALL DISCOVERY WORK WAS TO ADVANCE THE EXPLORATION ON ALL CLAIMS.

The total cost of such work consisted of at least \$ 500.00

The corners and side centers of the claim are located and marked as follows:

From the South west corner, a monument marked CRD#8 S.W. Cor, thence in a Northerly direction 325 feet to the South East corner, a monument marked CRD#8 S.E. Cor, thence 425 feet in a Northerly direction to the EAST side center, a monument marked CRD#8 East SC, thence 425 feet in a Northerly direction to the North East corner, a monument marked CRD#8 N.E. Cor, thence 425 feet in a Westerly direction to the North west corner, a monument marked CRD#8 N.W. Cor, thence 425 feet in a Southwesterly direction to the West side center, a monument marked CRD#8 West SC, thence 425 feet Southerly to the point of beginning.

Each of the above-described monuments is 4X4 Post - 4 $\frac{1}{2}$  feet in length.

All location and discovery work necessary to complete this location had been performed between Sep. 30/68 and October 1, 1968.
