

MEMORANDUM OF AGREEMENT

THIS AGREEMENT, made on the 26th day of August, 1968, between MAYNARD E. BISONI AND MARY BISONI, husband and wife; LESTER A. 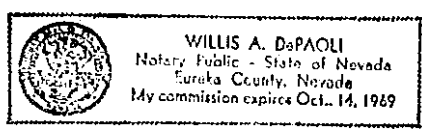

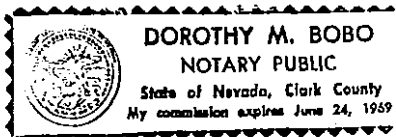
