as shown on the sketch, exposing ledge, lode, or vein in place.

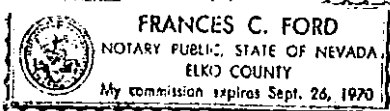

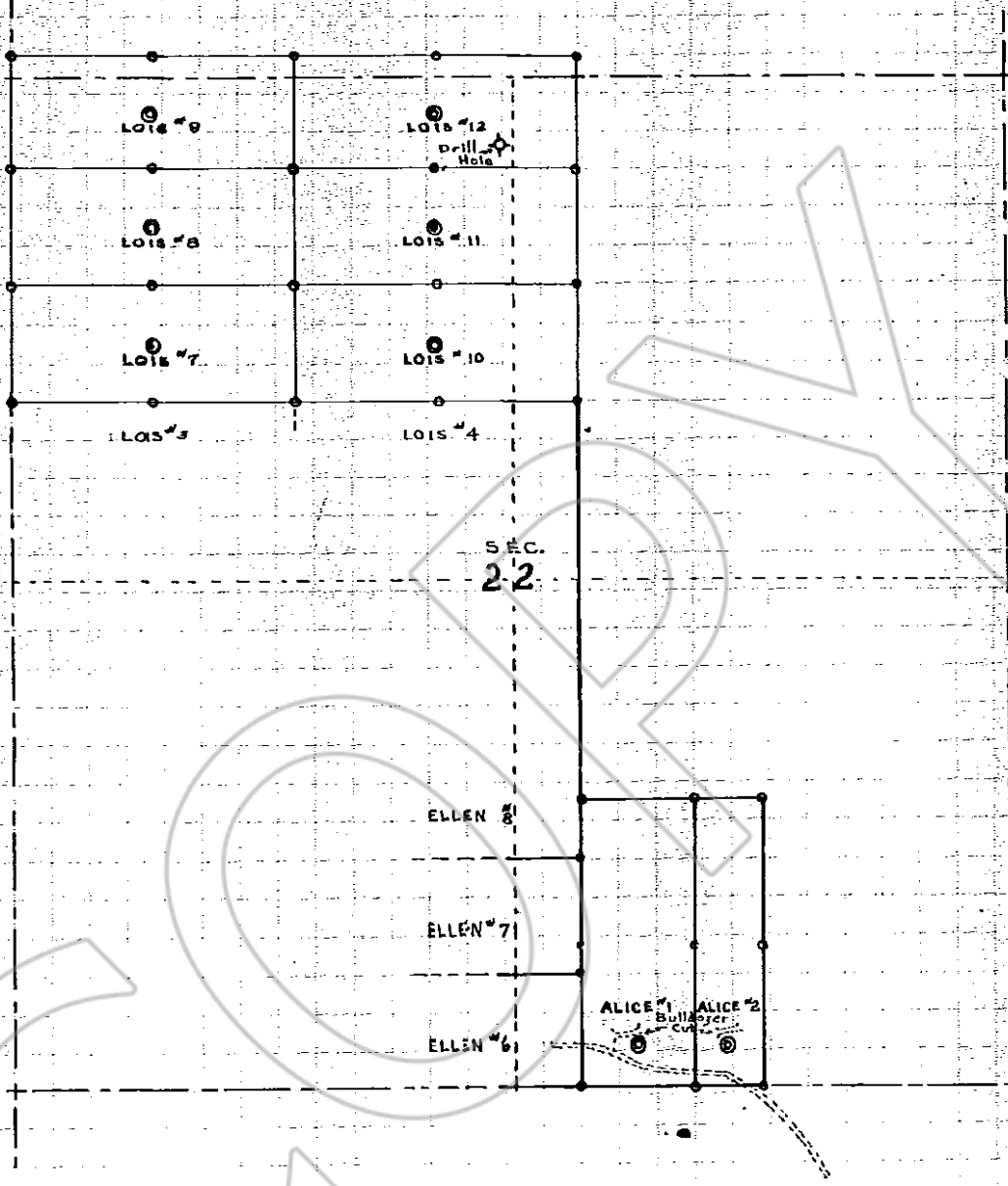
