## LOCATION CERTIFICATE

THIS IS TO CERTIFY that the J- 12 lode mining claim was located by Homestake Mining Company, whose present address is 650 California Street, San Francisco, California 94108, on the 57% day of September 1968.

The general course of said vein or lode as near as it may be described is easterly and westerly. The claim is situated in Unknown Mining District in Eureka County, State of Nevada, and the discovery monument is located approximately 3/00 feet westerly from the southeast corner of Section 22, Township 23 North, Range 49 East. The undersigned claims 50 feet in an easterly direction and 450 feet in a westerly direction from the point of discovery, with a width of 300 feet on each side of the center of the lode or vein along the entire length of the claim.

J- 12"; thence easterly 750 feet to the north side center post, a post of the same dimensions as that mentioned above surrounded by a mound of earth and stones as above described and marked "N Side Center J- 12-"; thence easterly 750 feet to the northeast corner, a post of the same dimensions surrounded by earth and stones as above set forth and marked "NE Cor. J- 12-"; thence southerly 600 feet to the southeast corner, a post of the same dimensions surrounded by earth and stones as above set forth and marked "SE Cor.
