

## LOCATION CERTIFICATE

THIS IS TO CERTIFY that the J- 29 lode mining claim was located by Homestake Mining Company, whose present address is 650 California Street, San Francisco, California 94108, on the 5th day of September 1968.

The general course of said vein or lode as near as it may be described is easterly and westerly. The claim is situated in Unknown Mining District in Eureka County, State of Nevada, and the discovery monument is located approximately 4600 feet westerly from the southeast corner of Section 22, Township 23 North, Range 49 East. The undersigned claims 50 feet in an easterly direction and 1450 feet in a westerly direction from the point of discovery, with a width of 300 feet on each side of the center of the lode or vein along the entire length of the claim.

This is one of a group of 9 contiguous claims to wit: \_\_\_\_\_

J-10, J-12, J-14, J-15, J-25, J-26, J-27, J-28, J-29

The discovery work for the benefit of the entire group was done on the claim or claims as follows: J-10, J-12, J-14, J-28, J-29

and consisted of: Drilling 4 holes on J-14, Drilling 1 hole on J-10, Bulldozing on J-14, J-28, J-29

The corners and side centers of the claim are located and marked as follows:

Beginning at the northwest corner a 4-inch by 4-inch by 4½ foot wooden post set in a mound of earth or stones 2 feet in height by 4 feet in diameter and marked "NW Cor. J- 29 "; thence easterly 750 feet to the north side center post, a post of the same dimensions as that mentioned above surrounded by a mound of earth and stones as above described and marked "N Side Center J- 29 "; thence easterly 750 feet to the northeast corner, a post of the same dimensions surrounded by earth and stones as above set forth and marked "NE Cor. J- 29 "; thence southerly 600 feet to the southeast corner, a post of the same dimensions surrounded by earth and stones as above set forth and marked "SE Cor. J- 29 "; thence westerly 750 feet to the south side center post, a post of the same dimensions surrounded by earth and stones as above set forth and marked "S Side Center J- 29 "; thence 750 feet westerly to the southwest corner of the claim a post of the same dimensions surrounded by earth and stones as above set forth and marked "SW Cor. J- 29 "; thence 600 feet northerly to the point of beginning.

All location work necessary to complete this location had been performed prior to 10-27, 1968.

The location work on the group of claims hereinbefore referred to cost at least \$ 900.
