

The undersigned, Grantors, grant to BELL TELEPHONE COMPANY OF NEVADA, a corporation, its successors and assigns, Grantee, a right of way, with the right to construct, place, inspect, maintain, remove, repair, replace, use, operate and patrol such aerial wires, cables and other electrical conductors with associated poles, crossarms, anchors, guys and fixtures, as Grantee may from time to time require, and with the right of access thereto, across and upon the following described property in the Counties of Eureka and Lander, State of Nevada:

The northwest quarter of the southwest quarter
of the southwest quarter (NW 1/4 of SW 1/4 of SW 1/4)
of Section 29, Township 29 North, Range 48 East, M.D.B.&M.

Said right of way is ten (10) feet in width, five (5) feet on each side of the following described centerline: Beginning at a point on the north line of the southwest quarter of the southwest quarter (SW 1/4 of SW 1/4) of said Section 29, from which point the northwest corner thereof bears west a distance of 25.00 feet; and running thence from said point of beginning south $01^{\circ} 04' 41''$ west a distance of 326.00 feet; thence south $09^{\circ} 35' 37''$ west a distance of 148.00 feet to a point on the west line of said Section 29.

Grantors also grant to Grantee the right to trim any trees along said wires, cables, conductors and poles whenever considered necessary by Grantee for the complete enjoyment of the rights hereby granted.
