10 ORDER SETTING ASIDE ESTATE WITHOUT

12 JULIA HUNT having filed herein a Petition to set aside

21 room of the Elko County Courthouse, Elko, Nevada, and oral and
22 documentary evidence having been introduced in support of the
23 Petition, and the Court having been duly advised in the premises;

24 THE COURT HEREBY FINDS AS FOLLOWS:

25 That Petitioner is a resident of the City of Elko,
26 County of Elko, State of Nevada, and is a surviving daughter and
27 sole heir of Decedent under the laws of the State of Nevada;
28 that Decedent passed away in the City of Elko, County of Elko,
29 State of Nevada, on December 4, 1966, leaving certain real
30 property in Eureka County, Nevada as her Estate; that there were
31 no liens or encumbrances of record on any of the properties com-
32 prising said Estate as of the date of Decedent's death; that the

1 value of the property was less than \$1,000.00, to-wit, not more
2 than the sum of \$500.00; that there are no minor children the
3 issue of Decedent and Petitioner is the sole heir of the Decedent
4 under the laws of the State of Nevada; that the property herein-
