ORDER SETTING ASIDE ESTATE WITHOUT
ADMINISTRATION

JULIA HUNT having filed herein a Petition to set aside
an Estate of not more than \$500.00, without administration, on
September 25, 1968, and notice of hearing of said Petition having
been duly given by posting as required by law, as established by
Affidavit of Posting on file herein, and said Petition having been
set for hearing for Tuesday, October 8, 1968, at the hour of
10:00 A.M., and said hearing having been duly carried forward to
the hour of 1:30 P.M., on the 14th day of November, 1968, and
having been duly and regularly heard at said time, in the Court-
room of the Elko County Courthouse, Elko, Nevada, and oral and
documentary evidence having been introduced in support of the
Petition, and the Court having been duly advised in the premises;

THE COURT HEREBY FINDS AS FOLLOWS:

That Petitioner is a resident of the City of Elko,
County of Elko, State of Nevada, and is a surviving daughter and
sole heir of Decedent under the laws of the State of Nevada;
that Decedent passed away in the City of Elko, County of Elko,
State of Nevada, on December 4, 1966, leaving certain real
property in Eureka County, Nevada as her Estate; that there were
no liens or encumbrances of record on any of the properties com-
prising said Estate as of the date of Decedent's death; that the

1 value of the property was less than \$1,000.00, to-wit, not more
 2 than the sum of \$500.00; that there are no minor children the
 3 issue of Decedent and Petitioner is the sole heir of the Decedent
 4 under the laws of the State of Nevada; that the property herein-
 5 after described comprising Decedent's Estate should be set aside
 6 unto JULIA HUNT.

7 WHEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

8 That the following described real property comprising
 9 Decedent's Estate be, and the same hereby is assigned and set
 10 apart unto JULIA HUNT, as the owner thereof:

 Eureka Mining District, Eureka County, Nevada.
