MINING DEED

THIS MINING DEED, made and entered into as of the 14th day of November, 1968, by and between JULIA HUNT, a widow, of the City of Elko, County of Elko, State of Nevada, First Party, and JEFF HUNT and LOUISE HUNT, his wife, of the same place, Second Party,

W I T N E S S E T H:

That the said First Party, for and in consideration of the sum of TEN DOLLARS (\$10.00), lawful money of the United States of America, to her in hand paid by the said Second Parties, and other good and valuable consideration, receipt whereof is hereby acknowledged, does by these presents grant, bargain, sell, remise, release and forever quitclaim unto the said Second Parties, as joint tenants with right of survivorship and not as tenants in common, and to the assigns of said Second Parties, and to the survivor of them, and to the heirs, executors, administrators and assigns of the survivor, all of that certain patented mining claim situate in the Eureka Mining District, County of Eureka, State of Nevada, more particularly described as follows, to-wit:

The Windfall Extension Fraction patented mining claim, U. S. Mineral Survey #4537, Eureka Mining District, Eureka County, Nevada.

TOGETHER WITH all improvements situate thereon, and all water rights.

TOGETHER WITH all the dips, spurs and angles, and also all the metals, ores, gold and silver bearing quartz, rock and earth therein; and all the rights, privileges and franchises thereto incident, appendant and appurtenant, or therewith usually had and enjoyed; and also all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, and the rents, issues and profits thereof.

TO HAVE AND TO HOLD the said premises, together with the appurtenances and privileges incident thereto, unto the said Second Parties, as joint tenants and not as tenants in common, and to the survivor forever.
