KNOW ALL MEN BY THESE PRESENTS:


That, for a consideration, the receipt of which is hereby acknowledged, **FIRST WESTERN SAVINGS AND LOAN ASSOCIATION** of Las Vegas, Nevada, hereby cancels and recinds the Notice of Breach heretofore given under the provisions of Section 7710 of Nevada Compiled Laws, as amended, which Notice was dated February 15, 1968 and recorded February 28, 1968, in Book 22, Page 539 of Official Records, as Document No. 46224 in the office of the County Recorder of Eureka County, Nevada; said Notice of Breach pertaining to the indebtedness evidenced by the promissory note mentioned as secured by that certain Deed of Trust dated July 14, 1965, recorded July 21, 1965, as Document No. 41069, records of said County, executed by Joseph H. Schuh and Karen M. 

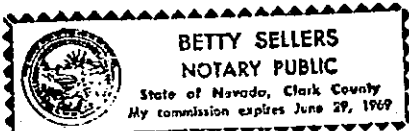


