the undersigned, ha<sup>s</sup> this 17th day of December, 1968,  
amended, located and claimed, and by these presents do<sup>es</sup> amend, locate, and claim, by right of dis-  
covery and this amended location certificate 1,500 linear feet and  
horizontal measurement on the BUDDY NO. 1 lode, vein, ledge or  
deposit, along the vein thereof, with all its dips, angles and variations, as allowed by law, together with  
300 feet on the Northerly side, and  
300 feet on the Southerly side of the
