KNOW ALL MEN BY THESE PRESENTS: That ALLEN RUSSELL

the undersigned, has this 17th day of December, 1968, amended, located and claimed, and by these presents do ~~es~~ amend, locate, and claim, by right of discovery and this amended location certificate 1,500 linear feet and horizontal measurement on the BUDDY NO. 2 lode, vein, ledge or deposit, along the vein thereof, with all its dips, angles and variations, as allowed by law, together with 300 feet on the Northerly side, and 300 feet on the Southerly side of the middle of said vein at the surface, so far as can be determined from present developments; and all veins, lodes, ledges or deposits and surface ground within the lines of said claim, 750 feet running Easterly from center of discovery monument and 750 feet running Westerly from center of discovery monument said discovery monument being situate upon said lode, vein, ledge, or deposit, and within the lines of said claim in

Cortez Mining District, County of Eureka Nevada and State of Colorado, described by metes and bounds as follows, to-wit:

Beginning at ~~Cortez~~ Northwest corner, a monument marked Buddy #2, NW cor; thence 600 ft Southwesterly to the Southwest corner, a monument marked Buddy #2, SW cor; thence 750 ft Southeasterly to the South side center, a monument marked Buddy #2, South SC; thence 750 ft Southeasterly to the Southeast corner, a monument marked Buddy #2, SE cor; thence 600 ft Northeasterly to the Northeast corner, a monument marked Buddy #2, NE cor; thence 750 ft Northwesterly to the North side center, a monument marked Buddy #2, North SC; thence 750 ft Northeasterly to the Northwest corner, the point of beginning.

This being the same lode originally located on the 15th day of April, 1968, and recorded on the 8th day of May, 1968, in Book 23, Page 564, in the office of the Recorder of Eureka County, this further and amended certificate of location is made without waiver of any previously acquired rights, but for the purpose of correcting any errors in the original location, description or record.
