the undersigned, ha. E. this 17th day of December, 1968,
amended, located and claimed, and by these presents do ^{es} amend, locate, and claim, by right of discovery and this amended location certificate 1,500 linear feet and
horizontal measurement on the BUDDY NO. 3 lode, vein, ledge or
deposit, along the vein thereof, with all its dips, angles and variations, as allowed by law, together with
300 feet on the Northerly side, and
300 feet on the Southerly side of the
middle of said vein at the surface, so far as can be determined from present developments; and all
veins, lodes, ledges or deposits and surface ground within the lines of said claim, 750
feet running Easterly from center of discovery monument
and 750 feet running Westerly
from center of discovery monument said discovery monument being situate
upon said lode, vein, ledge, or deposit, and within the lines of said claim in
