the undersigned, has this 17th day of DECEMBER, 1968,  
amended, located and claimed, and by these presents do <sup>ss</sup> amend, locate, and claim, by right of discovery and this amended location certificate 1,500 linear feet and  
horizontal measurement on the CORTEZ NO. 6 lode, vein, ledge or  
deposit, along the vein thereof, with all its dips, angles and variations, as allowed by law, together with  
300 feet on the Northwesterly side, and  
300 feet on the Southeasterly side of the  
middle of said vein at the surface, so far as can be determined from present developments; and all  
veins, lodes, ledges or deposits and surface ground within the lines of said claim, 10  
feet running Northeasterly from center of discovery <sup>at</sup> ~~center~~ monument  
and 1,490 feet running Southwesterly
