amended, located and claimed, and by these presents do<sup>es</sup> amend, locate, and claim, by right of discovery and this amended location certificate 1,500 linear feet and  
horizontal measurement on the CORTEZ NO. 8 lode, vein, ledge or  
deposit, along the vein thereof, with all its dips, angles and variations, as allowed by law, together with  
300 feet on the Northwesterly side, and
