KNOW ALL MEN BY THESE PRESENTS: That ALLEN RUSSELL

the undersigned, has this 17th day of DECEMBER, 1968,  
amended, located and claimed, and by these presents do ~~do~~ amend, locate, and claim, by right of discovery and this amended location certificate 1,500 linear feet and horizontal measurement on the HELEN NO. 2 lode, vein, ledge or deposit, along the vein thereof, with all its dips, angles and variations, as allowed by law, together with 300 feet on the Northeasterly side, and 300 feet on the Southwesterly side of the middle of said vein at the surface, so far as can be determined from present developments; and all veins, lodes, ledges or deposits and surface ground within the lines of said claim, 750 feet running Northwesterly from center of discovery monument and 750 feet running Southeasterly from center of discovery monument said discovery monument being situate upon said lode, vein, ledge, or deposit, and within the lines of said claim in

Cortez Mining District, County of Eureka and State of Nevada, described by metes and bounds as follows, to-wit:  
Beginning at Corner No. 1 Northwest corner, a post marked Helen #2, NW cor; thence 600 ft Southwesterly to the Southwest corner, a post marked Helen #2, SW cor; thence 750 ft Southeasterly to the South side center, a post marked Helen #2, South SC; thence 750 ft Southeasterly to the Southeast corner, a post marked Helen #2, SE cor; thence 600 ft Northeasterly to the Northeast corner, a post marked Helen #2, NE cor; thence 750 ft Northwesterly to the North Side Center, a post marked Helen #2, North SC; thence 750 ft Northwesterly to the Northwest corner, the point of beginning.

This being the same lode originally located on the 19th day of June, 1950, and recorded on the 1st day of September, 1950, in Book J, Page 18, in the office of the Recorder of Eureka County, this further and amended certificate of location is made without waiver of any previously acquired rights, but for the purpose of correcting any errors in the original location, description or record. This certificate corrects a typographical or clerical error in the original, and the Location Notice has not been amended.
