KNOW ALL MEN BY THESE PRESENTS: That ALLEN RUSSELL

the undersigned, has as this 17th day of DECEMBER, 1968, amended, located and claimed, and by these presents do hereby amend, locate, and claim, by right of discovery and this amended location certificate. 1,500 linear feet and horizontal measurement on the IDA NO. 2 lode, vein, ledge or deposit, along the vein thereof, with all its dips, angles and variations, as allowed by law, together with 300 feet on the Northwesterly side, and 300 feet on the Southeasterly side of the middle of said vein at the surface, so far as can be determined from present developments; and all veins, lodes, ledges or deposits and surface ground within the lines of said claim, 1,200 feet running Northeasterly from center of discovery monument and 300 feet running Southwesterly from center of discovery monument said discovery monument being situated upon said lode, vein, ledge, or deposit, and within the lines of said claim in

Cortez Mining District, County of Eureka Nevada and State of Colorado, described by metes and bounds as follows, to-wit:

Beginning at Corner Next Northwest corner, a post marked Ida #2, NW Cor; thence 600 ft Southeast to the Southwest corner, a post marked Ida #2, SW Cor; thence 750 ft Northeast to the South side center, a post marked Ida #2, South SC; thence 750 ft Northeast to the Southeast corner, a post marked Ida #2, SE Cor; thence 600 ft Northwest to the Northeast corner, a post marked Ida #2, NE Cor; thence 750 ft Southwest to the North side center, a post marked North SC; thence 750 ft Southwest to the Northwest corner, the point of beginning.

This being the same lode originally located on the 6th day of March, 1968, and recorded on the 6th day of May, 1968, in Book 23, Page 566, in the office of the Recorder of Eureka County, this further and amended certificate of location is made without waiver of any previously acquired rights, but for the purpose of correcting any errors in the original location, description or record. This certificate corrects a typographical or clerical error in the original, and the Location Notice has not been amended.
