KNOW ALL MEN BY THESE PRESENTS: That ALLEN RUSSELL

the undersigned, has this 17th day of DECEMBER, 1968,
amended, located and claimed, and by these presents do amend, locate, and claim, by right of discovery and this amended location certificate 1,500 linear feet and horizontal measurement on the IDA NO. 4 lode, vein, ledge or deposit, along the vein thereof, with all its dips, angles and variations, as allowed by law, together with 300 feet on the Northeasterly side, and 300 feet on the Southwesterly side of the middle of said vein at the surface, so far as can be determined from present developments; and all veins, lodes, ledges or deposits and surface ground within the lines of said claim, 1,200 feet running Northwesterly from center of discovery monument and 300 feet running Southeasterly from center of discovery monument said discovery monument being situated upon said lode, vein, ledge, or deposit, and within the lines of said claim in
