KNOW ALL MEN BY THESE PRESENTS: That ALLEN RUSSELL

the undersigned, ha^s this 17th day of DECEMBER, 1968,
amended, located and claimed, and by these presents do^{es} amend, locate, and claim, by right of discovery and this amended location certificate 1,500 linear feet and horizontal measurement on the JOSEPHINE lode, vein, ledge or deposit, along the vein thereof, with all its dips, angles and variations, as allowed by law, together with 300 feet on the Northeasterly side, and 300 feet on the Southwesterly side of the middle of said vein at the surface, so far as can be determined from present developments; and all veins, lodes, ledges or deposits and surface ground within the lines of said claim, 100 feet running Southeasterly from center of discovery 1/4 section monument and 1,400 feet running Northwesterly from center of discovery 1/4 section monument said discovery 1/4 section monument being situate upon said lode, vein, ledge, or deposit, and within the lines of said claim in

Cortez Mining District, County of Eureka and State of Nevada, described by metes and bounds as follows, to-wit:
Beginning at ~~Corner~~ Northwest corner, a stake marked NW Cor #1, Josephine; thence Southeasterly 750 ft to West side cor, a stake marked West SC, Josephine; thence Southeasterly 750 ft to Southwest corner, a stake marked SW Cor #2, Josephine; thence 600 ft Northoasterly to Southeast corner, a stake marked SE Cor #3, Josephine; thence 750 ft Northwesterly to North side cor, a stake marked North SC, Josephine; thence 750 ft to Northeast corner, a stake marked NE Cor #4, Josephine; thence 600 ft Southwesterly to the point of beginning.

This being the same lode originally located on the 24th day of June, 1950, and recorded on the 16th day of September, 1950, in Book J, Page 19, in the office of the Recorder of Eureka County, this further and amended certificate of location is made without waiver of any previously acquired rights, but for the purpose of correcting any errors in the original location, description or record. This certificate corrects a typographical or clerical error in the original, and the Location Notice has not been amended.
