

1 ASSIGNMENT OF PROMISSORY NOTE AND DEED OF TRUST

3 WHEREAS, on the 21st day of November, 1968, SONIA S.  
4 WALKER, a married man, made and delivered to LEE HALE & CO., INC.,  
5 a Nevada Corporation, a certain promissory note in the amount of  
6 \$9,367.91, which said promissory note was secured by a Deed of  
7 Trust of even date with said note in which Deed of Trust SONIA  
8 S. WALKER is Trustor, LAWYERS TITLE INSURANCE CORPORATION, a  
9 Nevada Corporation, is Trustee and LEE HALE & CO., INC., is  
10 Beneficiary, which Deed of Trust was recorded as Document  
11 No. 48178 , in Book 26 , Page 525 , ~~Deeds of Trust~~, Records of  
12 Eureka County, Nevada, on OFFICIAL RECORDS

13 NOW, THEREFORE, LEE HALE & CO., INC., a Nevada Corporation,  
14 in consideration of Ten Dollars (\$10.00) and other good and  
15 valuable consideration to it in hand paid, receipt whereof hereby  
16 is acknowledged, hereby does assign and transfer, without recourse  
17 unto JEANETTE PIERCE, a single woman, MILDRED GRAFF, a married  
18 woman, and NORMA ROGERS, a married woman, as Joint Tenants, that  
19 certain promissory note and Deed of Trust aforesaid, together  
20 with all of its right, title and interest therein, the monies  
21 due or to become due upon said promissory note and upon the  
22 obligations of Trustors in said Deed of Trust; and it hereby  
23 does irrevocably authorize and empower the Trustee under said  
24 Deed of Trust to recognize and substitute the said JEANETTE PIERCE,  
25 MILDRED GRAFF, and NORMA ROGERS as the sole Beneficiaries of said  
26 Deed of Trust, to the same intent and purpose as though the said  
27 JEANETTE PIERCE, MILDRED GRAFF and NORMA ROGERS were originally  
28 named in said Deed of Trust as sole Beneficiaries, and does  
29 further assign and transfer unto JEANETTE PIERCE, MILDRED GRAFF,  
30 and NORMA ROGERS all of the right which it may now have or  
hereafter acquire in connection with any and all provisions, terms  
and conditions contained in the aforesaid promissory note and  
Deed of Trust and the obligations secured thereby.

IN WITNESS WHEREOF, LEE HALE & CO., INC., a Nevada  
Corporation, has executed this assignment of promissory note and  
Deed of Trust this 20<sup>th</sup> day of December, 1968.

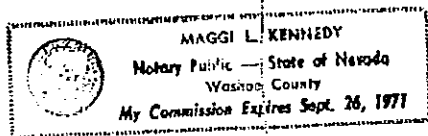
