

POWER OF ATTORNEY

other instruments in writing of whatever kind and nature as may be necessary, convenient or proper in the premises; also, in case of loss by fire or otherwise to adjust insurance losses.

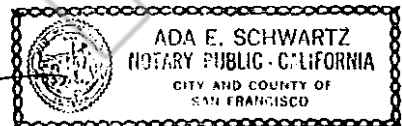
