

CERTIFICATE OF LOCATION OF MILLSITE CLAIM

NOTICE OF LOCATION

NOTICE IS HEREBY GIVEN that the undersigned citizen of the United States hereby locates and claims the following described piece of ground as a Millsite Claim. From this location monument 362.5 feet in a N.Westerly direction, 362.5 feet in a S.Easterly direction, 150 feet in a N.Easterly direction and 150 feet in a S.Westerly direction.

The northwest corner of this claim is situate approximately 23,008 feet north and approximately 10,607 feet west of the southwest corner of Section 6, T. 26 N., R. 48 E., MDB&M.

The general course of the claim is N.Westerly and S.Easterly, and the size of the claim is 725 feet long by 300 feet wide, and contains approximately 5 acres. This claim shall be known as the M 245, situate in the Cortez Mining District, Lander and/or Eureka Counties, Nevada.

The Locator is the owner and proprietor of the ADA 17-33, the ADA 49-53, the ADA 60-64, and other lode mining claims in this District.

The corners and side centers of said claim are located and marked as follows: Beginning at the northwest corner, a monument marked NW COR M 245; thence 300 feet in a northeasterly direction to the northeast corner, a monument marked NE COR M 245; thence 362.5 feet in a southeasterly direction to the east side center, a monument marked ESC M 245; thence 362.5 feet in a southeasterly direction to the southeast corner, a monument marked SE COR M 245; thence 300 feet in a southwesterly direction to the southwest corner, a monument marked SW COR M 245; thence 362.5 feet in a northwesterly direction to the west side center, a monument marked WSC M 245; thence 362.5 feet in a northwesterly direction to the point of beginning.

Each of the above-described monuments is a 4" x 4" post, 4½ feet long, set one foot of its length in the ground. Markings are on metal tags affixed to said posts.

All work necessary to complete this location had been completed by January 29, 1969.
