THIS INDENTURE, made and entered into this 29th day of January, 1969, by and between CRESCENT VALLEY RANCH & FARMS, a Nevada corporation, party of the first part, and OPAL J. WISE, an unmarried woman, party of the second part, of 13900 Marquess Way, #A-8-, Marina Del Rey, California 90291,

**WITNESSETH:**

That the said party of the first part, in consideration of the sum of TENDOLLARS (\$10.00), lawful money of the United States of America, to it in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, does by these presents grant, bargain and sell unto the said party of the second part and to her heirs and assigns forever, all that certain parcel of land situate in the County of Eureka, State of Nevada, described as follows:

RESERVING, THEREFROM, an easement of 30' along all boundaries for ingress and egress, with power to dedicate, and, except any and all all rights, including the right of entry for exploration and production of oil or other carbohydrates.
