THIS INDENTURE made this 10 day of March, 1969, by and between H. G. METOS and GRACE M. METOS, his wife, Parties of the First Part, and SILVER WEST MINING COMPANY, a Utah corporation, Party of the Second Part;

W I T N E S S E T H :
