

Certificate of Location of Lode Mining Claim

THIS IS TO CERTIFY that the U. S. A. Reid no. 26 Lode Mining Claim was located by Mr and Mrs Wallace Wm. Holt, whose post office address appears below, on the 20th day of January, 1969.

The general course of said lode or vein is Northerly and Southerly

The claim is situated in the Diamond Mining District, Eureka County, State of Nevada, Northerly of Azimuth mark U.S. Coast and Geodetic Survey Bench Mark 8AAU.S.G.S Monument on the Westerly Southerly side.

The locator claim 750 feet in a Easterly direction and 750 feet in a Westerly direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows: A shaft 3 feet by 12 feet, sunk 7 feet deep at the point of claim midway between U. S. A. Reid no. 26 on the Southerly line.

The total cost of such work consisted of at least \$100.00

The corners and side centers of the claim are located and marked as follows:

From the South West corner, a monument marked U.S.A. Reid no. 26 cor., thence in a Northerly direction 600 feet to the North Westerly corner, a monument marked U.S.A. Reid no. 26 Cor., thence 750 feet in a Easterly direction to the Northerly side center, a monument marked U.S.A. Reid no. 26 SC, thence 750 feet in a Easterly direction to the North Easterly corner, a monument marked U.S.A. Reid no. 26 Cor., thence 600 feet in a Southerly direction to the South Easterly corner, a monument marked U.S.A. Reid no. 26 Cor., thence 750 feet in a Westerly direction to the Southerly side center, a monument marked U.S.A. Reid no. 26 SC, thence 750 feet Westerly to the point of beginning.

A post at least 4 inches in diameter by 4 feet

Each of the above-described monuments is 6 inches in length set 1 foot in the ground.

All location and discovery work necessary to complete this location had been performed by April 7, 1969.
