

THE STATE OF NEVADA.

TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

Whereas, Thomas Griffin of Eureka County, Nevada has deposited with the Register of the State Land Office at Carson City the State Treasurer's Receipt, whereby it appears that full payment has been made by the said Thomas Griffin according to the provisions of an Act of the Legislature, approved March 12, 1885, entitled "An Act to provide for the selection and sale of lands that have been or may hereafter be granted by the United States to the State of Nevada," and the Acts amendatory thereof and supplementary thereto, for the North West Quarter of the South West Quarter and the West half of the North West Quarter of Section Twenty (20) Township Thirty-two (32) North Range Fifty-two (52) East

Mount Diablo Base and Meridian, containing Three and one-half (3 1/2) acres, according to the Official Plat of the survey of Public Lands, as made by the United States Surveyor-General for the District of Nevada, which said tract has been purchased by the said Thomas Griffin

THEREFORE, KNOW YE, that the State of Nevada, in consideration of the premises, and in conformity with the Act of the Legislature in such cases made and provided, has given and granted, and by these presents does give and grant, unto the said Thomas Griffin and to his heirs, the said tract above described, TO HAVE AND TO HOLD the same, together with all rights, privileges, immunities and appurtenances of whatever nature thereunto belonging, unto the said Thomas Griffin and to his heirs and assigns forever; provided, that all mines of gold, silver, copper, lead, clambarr and other valuable minerals that may exist in said tract are hereby expressly reserved.
