JUDGMENT SETTLING FIRST AND FINAL
ACCOUNT AND REPORT OF EXECUTOR FOR
ALLOWANCE OF COMMISSIONS AND FEES
AND FOR FINAL DISTRIBUTION.

LAWRENCE VACCAREZZA, as executor of the estate of FRANK VACCAREZZA, deceased, having heretofore filed his first and final account and report and petition for its settlement and for final distribution, and the account and report and petition coming on this day regularly for hearing, the court finds:

Due notice of the hearing of the petition has been regularly given as required by law.

All the allegations of the petition are true.

FRANK VACCAREZZA died testate on May 14, 1968 in the County of San Joaquin, State of California being at the time of his death a resident thereof.

On June 3, 1968, LAWRENCE VACCAREZZA was appointed executor of the decedent's estate. He qualified as executor of the decedent's estate on June 3, 1968 and ever since has been and now is the executor of the decedent's estate.

Notice to creditors has been duly given as required by law, the time for filing or presenting claims has expired and the estate now is in a condition to be closed.

All claims filed or presented against the estate have been allowed by the executor, and approved by this Court and paid.

All debts of the decedent and of the estate and all expenses

of administration have been paid.

A written report of the inheritance tax appraiser appointed herein is on file, and an order fixing the inheritance tax due the State of California from this estate has been made by this Court. The tax has been paid in full as evidenced by the receipt of the County Treasurer of the County of San Joaquin on file herein.

A Federal estate tax return has been made and filed for this estate and the tax shown to be due has been paid. The return has not yet been audited.

All California income taxes and Federal income taxes due and payable by the estate has been paid.

The payment of the sum of \$2450.35 by the executor to himself as payment in full of his statutory commissions for his services rendered in the administration of this estate and the payment of the sum of \$2450.35 to A. B. HENNING, as payment in full of his statutory fees for his services rendered in the administration of this estate should be approved.

That MARIA VACCAREZZA, mother of decedent and beneficiary under the trust created under this Will died before distribution. Therefore distribution in trust for the benefit of her lapsed.

That Steve Vaccarezza, Paul Vaccarezza and Janet Vaccarezza all are under the age of twenty-one (21) and therefore distribution is asked to LAWRENCE VACCAREZZA, father of said children. Said inheritance to be deposited in the Bank of Stockton in a savings account subject to withdrawal only upon further order of this Court.

All the assets of the estate are the separate property of the decedent.

Distribution should be ordered as hereafter specified:

IT IS ORDERED AND ADJUDGED THAT:

1. The administration of the estate is brought to a close.
2. The first and final account, petition and report of the

executor is settled, allowed, and approved as filed.

3. All the acts and transactions of the executor relating to the matters set forth in the account, petition and report are ratified, confirmed, and approved.

4. The payment of the sum of \$2450.95 by the executor to himself as payment in full of his statutory commissions for his services rendered in the administration of this estate, and the payment of the sum of \$2450.35 to A. B. HENNING, his attorney, as payment in full of his statutory fees for his services rendered in the administration of this estate is approved.

5. Notice to creditors has been duly given as required by law.

6. The California inheritance taxes due and payable by the estate have been paid.

7. The executor is authorized to deduct from the distributive shares of the persons hereafter named the sum set opposite his respective name, for inheritance taxes paid by the executor in his behalf as follows:

8. The estate in the possession of the executor remaining for distribution after the payments and withholding herein ordered in paragraphs 4 and 7 immediately above this paragraph consisting of the following described property which is distributed in the following manner:

To LENA VACCAREZZA, the sum of \$2500.00 less \$220.00 inheritance Tax or the sum of \$2280.00.

To EMIL VACCAREZZ JR. the sum of \$2500.00 less \$30.00 inheritance tax or \$2470.00.

To Carolyn DELCARLO the sum of \$2500.00 less \$30.00 Inheritance Tax or \$2470.00.

To STEVE VACCAREZZA the sum of \$2500.00 less \$30.00 inheritance tax or \$2470.00.

To PAUL VACCAREZZA the sum of \$2500.00 less \$30.00 inheritance tax or \$2470.00.

to JANET VACCAREZZA, the sum of \$2500.00 less \$30.00 Inheritance Tax or the sum of \$2470.00.

To LAWRENCE VACCAREZZA all the rest residue and remainder of the estate.

9. Any other property of the estate not now known or discovered which may belong to the estate, or in which the decedent or the estate may have any interest, is distributed to LAWRENCE VACCAREZZA.

10. Upon payment of said sums as set forth said Petitioner, after filing the receipts therefore the executor is hereby discharged.
