

Certificate of Location of Lode Mining Claim

THIS IS TO CERTIFY that the "DIXIE LEA, No. 1" Lode Mining Claim was located by Franklin E. Batt, Jack M. Holmes and Albert E. Cole, whose post office address appears below, on the 17 th. day of May, 19 69.

The general course of said lode or vein is North and South.

The claim is situated in the Lynn Creek Mining District, Eureka County, State of Nevada, N.W. $\frac{1}{4}$, Sec. 18, T. 35 No. R. 51 E.

The locator's claim 1500 feet in a Northerly direction and feet in a direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows:

Open trench, App. 5 ft. wide, 10 ft. long and app. 4 ft. deep,

100 ft. North, and app. parallel, with North side boundary, of

"Bonanza No. 1" placer claim, and "Back Pay No. 1" lode claims.

The total cost of such work consisted of at least \$ 100.00

The corners and side centers of the claim are located and marked as follows:

From the S.E. corner, a monument marked S.E. Cor., thence in a Westerly direction 600 feet to the S.W. corner, a monument marked S.W. Cor., thence 750 feet in a Northerly direction to the West side center, a monument marked West SC, thence 750 feet in a Northerly direction to the N.W. corner, a monument marked N.W. Cor., thence 600 feet in a Easterly direction to the N.E. corner, a monument marked N.E. Cor., thence 750 feet in a Southerly direction to the East side center, a monument marked East SC, thence 750 feet to the point of beginning.

Each of the above-described monuments is 4 in. by 4 in. post, 3 ft. above ground.

All location and discovery work necessary to complete this location had been performed by May 25, 19 69.
