

# Certificate of Location

THIS IS TO CERTIFY that the Bowser 37-A lode mining claim was located by Mount Hope Mines Company on the 30th day of April, 19 69.

The general course of said lode or vein is northerly & southerly

The claim is situated in the Mount Hope Mining District, Eureka County, State of Nevada. This claim is situated 2000 feet north of Mount Hope Peak and adjoins Bowser 37 on the north end line and overlaps Bowser 69, Bowser 70 and Bowser 63 on the west side line and adjoins Bowser 35-A on the east side line. The locator claims 25 feet in a(n) northerly direction and 1475 feet in a(n) southerly direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows: Location work for Bowser 31-A, Bowser 33-A, Bowser 35-A, Bowser 37-A was done as a group. These claims are contiguous. Starting approximately 200 ft. south of the center of claim Bowser 37-A a cut 10 ft. wide, 3 ft. deep, 400 ft. long running easterly & westerly. At least \$400.00 work done on these claims.

The corners and side centers of the claim are located and marked as follows: from the southwest corner a post marked Bowser 37-A S.W. Cor., Thence in an easterly direction 600 ft. to the southeast corner, a post marked Bowser 37-A S.E. Cor., Thence 750 ft. in a northerly direction to the east side center a post marked Bowser 37-A E.S.C., Thence 750 ft. in a northerly direction to the northeast corner a post marked Bowser 37-A N.E. Cor., Thence 600 ft. westerly to the northwest corner a post marked Bowser 37-A N.W. Cor., Thence 750 ft. in a southerly direction to the west side center a post marked Bowser 37-A W.S.C., Thence 750 ft. in a southerly direction to the point of beginning.

Each of the above-described monuments is a post at least 4 inches in diameter by 4 feet 6 inches in length, set 1 foot in the ground.

All location and discovery work necessary to complete this location had been performed by June 1, 19 69.
