

SUBSTITUTION OF TRUSTEE

WHEREAS, by Deed of Trust dated March 9, 1965, recorded March 10, 1965, in Book 6 Official Records, page 566-571, Eureka County Records, Eureka, Nevada, the PIONEER TITLE INSURANCE COMPANY OF NEVADA, a Nevada corporation, was designated Trustee in said Deed of Trust for the uses and purposes therein provided. That said Deed of Trust adopted Covenant No. 9 of N.R.S. 107.030, granting to the Beneficiaries the right to appoint another Trustee to execute the trusts created by the Deed of Trust; and

WHEREAS, the present Beneficiaries of said Deed of Trust desire to substitute JOSEPH O. McDANIEL of the firm of VAUGHAN, HULL, McDANIEL AND MARFISI, 530 Idaho Street, Elko, Nevada, for PIONEER TITLE INSURANCE COMPANY OF NEVADA, as Trustee in said Deed of Trust;

NOW THEREFORE, the appointment of PIONEER TITLE INSURANCE COMPANY OF NEVADA, a corporation, as Trustee, is hereby revoked and JOSEPH O. McDANIEL of the firm of VAUGHAN, HULL, McDANIEL & MARFISI, 530 Idaho Street, Elko, Nevada, is hereby nominated and appointed Trustee of said Deed of Trust for the uses and purposes therein provided and all right, title, estate and interest of the PIONEER TITLE

INSURANCE COMPANY of Nevada, in and to the property described in said Deed of Trust as Trustee, is hereby quitclaimed and conveyed, without warranty to the new Trustee, JOSEPH O. McDANIEL, to the same extent and purpose as if named as the original Trustee therein.
