NOTICE IS HEREBY GIVEN, That the undersigned, having complied with the requirements of SECTION 2324 of the REVISED STATUTES of the United States, and the Local Laws, Customs and Regulations of this District, ha located 1500 feet in length by 600 feet in width, on this the QUEEN ANN NO. 10 Lode, Vein or Deposit, bearing Gold, Silver, Copper, Lead and other valuable minerals, ~~discovery~~ The discovery monument of this claim is located 1500 feet South; thence 100 feet East from the S.E. Corner of Section 12, T 34 N, R 51 E, MDB&M.

in the unknown Mining District, Eureka County, State of Nevada,

the location being described and marked on the ground as follows, to-wit:

Beginning 1400 feet East of this location (Discovery) Monument, at the East end center monument, and running South 300 feet to S.E. corner monument No. 1; thence West 750 feet to South center side line monument No. 2; thence North 1500 feet to SW corner monument No. 2; thence North 600 feet to NW corner monument No. 3; thence East 750 feet to North center side line monument No. 3; thence East 750 feet to NE corner monument No. 4, thence South 300 feet to place of beginning; including all Dips, Spurs.

South Side line of Queen Ann No. 10 adjoins North side line of Queen Ann No. 11  
North side line of Queen Ann No. 10 adjoins South side line of Queen Ann No. 9

†Diagram of Claim—The location (discovery point) and corner monuments should be designated on the accompanying diagram to make the Record of claim more perfect.

A mining claim must not exceed 1500 feet in length along the vein or lode; by 600 feet in width, 300 feet on each side of center of vein at surface.

No location of a mining claim can be made until the discovery of the vein or lode within the limits of the ground claimed.

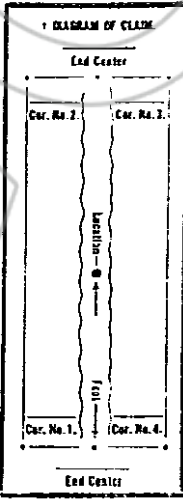
The claim must be distinctly marked on the ground, so its boundaries can be readily traced.

Claims located on Sundays or holidays are legal.

All valuable mineral deposits in land of the Government are locatable by citizens of the United States only, and those who have declared their intentions to become such.

This location notice must be filed for Record with the County Recorder of the county in which the claim is filed.
