**NOTICE IS HEREBY GIVEN**, That the undersigned, having complied with the requirements of SECTION 2324 of the REVISED STATUTES of the United States, and the Local Laws, Customs and Regulations of this District, ha located 1500 feet in length by 600 feet in width, on this the QUEEN ANN NO. 12 Lode, Vein or Deposit, bearing Gold, Silver, Copper, Lead and other valuable minerals, ~~MINED~~ The discovery monument of this claim is located 2700 feet South; thence 100 feet East from the S.E. Corner of Section 12, T 34 N, R 51 E, MDB&N.

in the Unknown Mining District, Eureka County, State of Nevada

the location being described and marked on the ground as follows, to-wit:

Beginning 1400 feet East of this location (Discovery; 700 South) Monument, at the East end center monument, and running thence South 300 feet to S E corner monument No. 1; thence West 750 feet to South S W center side line monument; thence West 750 feet to S W N W corner monument No. 2; thence North 600 feet to N W corner monument No. 3; thence East 750 feet to North N E center side line monument; thence East 750 feet to N E S E corner monument No. 4; thence South 300 feet to place of beginning; including all Dips, Spurs.

East end line of Queen Ann No. 12 adjoins West end line of Queen Ann No. 21  
South side line of Queen Ann No. 12 adjoins North side line of Queen Ann No. 13  
North side line of Queen Ann No. 12 adjoins South side line of Queen Ann No. 11

†Diagram of Claim—The location (discovery point) and corner monuments should be designated on the accompanying diagram to make the Record of claim more perfect.

A mining claim must not exceed 1500 feet in length along the vein or lode by 600 feet in width, 300 feet on each side of center of vein at surface.

No location of a mining claim can be made until the discovery of the vein or lode within the limits of the ground claimed.

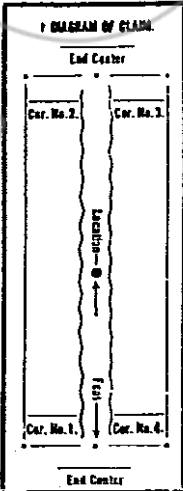
The claim must be distinctly marked on the ground, so its boundaries can be readily traced.
