NOTICE IS HEREBY GIVEN, That the undersigned, having complied with the requirements of SECTION 2324 of the REVISED STATUTES of the United States, and the Local Laws, Customs and Regulations of this District, ha located 1500 feet in length by 600 feet in width, on this the QUEEN ANN NO. 32 Lode, Vein or Deposit, bearing Gold, Silver, Copper, Lead and other valuable minerals, situated The discovery monument of this claim is located 3900 feet South; thence 3100 feet East from the S. E. Corner of Section 12, T 34 N, R 51 E, MDB&M.

in the Unknown Mining District, Eureka County, State of Nevada

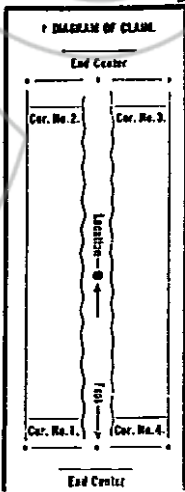
East end line of Queen Ann No. 32 adjoins West end line of Queen Ann No. 41

 †Diagram of Claim—The location (discovery point) and corner monuments should be designated on the accompanying diagram to make the Record of claim more perfect.
 A mining claim must not exceed 1500 feet in length along the vein or lode by 600 feet in width, 300 feet on each side of center of vein at surface.
 No location of a mining claim can be made until the discovery of the vein or lode within the limits of the ground claimed.
 The claim must be distinctly marked on the ground, so its boundaries can be readily traced.
 A severe penalty is provided by law for removing or defacing the stakes or monuments of a mining claim.
 Claims located on Sundays or holidays are legal.
 All valuable mineral deposits in land of the Government are locatable by citizens of the United States only, and those who have declared their intentions to become such.
