NOTICE IS HEREBY GIVEN, That the undersigned, having complied with the requirements of SECTION 2324 of the REVISED STATUTES of the United States, and the Local Laws, Customs and Regulations of this District, ha located 1500 feet in length by 600 feet in width, on this the QUEEN ANN NO. 33 Lode, Vein or Deposit, bearing Gold, Silver, Copper, Lead and other valuable minerals, ~~discovered~~ The discovery monument of this claim is located 4500 feet South; thence 3100 East from the S. E. Corner of Section 12, T 34 N, R 51 E, MDB&M.

No location of a mining claim can be made until the discovery of the vein or lode within the limits of the ground claimed.

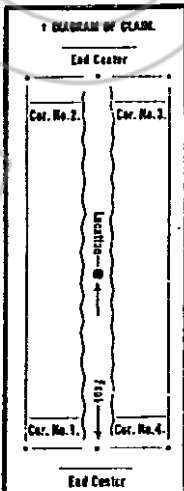
The claim must be distinctly marked on the ground, so its boundaries can be readily traced.
